8. Planning Matters.

New applications:

Minute 08037. Council objected to the following:

08/01484 – Glencoe, Main Street – Resiting of railings and gate. It was considered to have an adverse effect on the character and appearance of the conservation area.

08/01813 – **Linden Lea, Elvington Lane** – Certificate of lawfulness for caravan site. It was considered that the original consent has lapsed; the site is in Green Belt and that current Planning Policies should govern any new application.

Cllr Bailey declared a personal and prejudicial interest for the next two items, made a statement but then left the room and took no part in the discussion or vote.

Minute 08038. Council objected to the following:

08/01868 - The Villa, Main Street - Erection of bungalow to rear (resubmission).

Council's objections to the original application and revised scheme still apply.

08/01128 – Halgarth House, 1 Dovecote Garth – Extensions. It was considered that the front elevation is overdevelopment and out of character to existing frontages on Main Street.

The following Approval was noted:

08/01299 - 11 Riverside - Extension

The following Refusals were noted:

08/00892 - The Villa, Main Street - New building to rear (revised scheme)

08/01483 - Coach House, Elvington Lane - Extensions

Other matters: The following Withdrawals were noted:

08/00495 and **497 – Roxby Farm, Main Street** – Withdrawal of demolition of Barn 2 **08/01221 – Mill House, Manor House Farm** – Withdrawal of extensions

Airfield. Cllr Bailey said that the letter received from CYC and posted on the website gives the latest situation.

- **9. Reports from recent meetings**. Cllr Nicholson reported on the developments of the Allotment Association. Land is still being sought.
- Cllr Bailey reported on the Ward Committee and Website meetings.
- Cllr Wilson reported on Village Hall. Bandits on the Bridge had been successful if wet! The Clerk reported on the Air Museum 'A' Bomb & Humanity exhibition.
- Housing Needs Survey. Council decided that the survey did not demonstrate a need for further housing. The Conifers already provides for this need.
- **11. Maze.** The arrangements for traffic management were discussed. A dialogue with CYC will be sought to review the size of the signage and its removal after the Maze season. **IB/DH**
- **12. Highways, paths and verges.** The Clerk reported on work this month. New items were left side of bridge on Green; water leak outside Mallard and surplus posts. **DH**
- **13. Flooding Matters.** Cllr Bailey will seek meeting with CYC to clarify procedures. **IB** CYC will be asked to clear the culvert under Dauby Lane. **DH**
- **14. Village Green.** Due to an objection to Registration instigated by one householder, a Statement of Case has had to be prepared for the Land Registry Adjudicator. This has been submitted. Council noted that our Solicitors consider we will be successful and are confident of being able to reclaim costs, which are currently in excess of £3000.
- 15. Mast/Turbine. No meeting has taken place recently.
- **16. Bus Services.** Proposals for revised services after March 09 have been received. Cllrs will review and discuss next month. A dialogue with CYC will be sought. **ALL/IB/DH**
- Notice boards. It was agreed to refurbish the Elvington Park notice board.
