08/02438 – 2 Blacksmiths Cottage, Main Street – Bungalow attached to garage (resubmission). Cllr Forster declared a personal interest.

Minute 08054. Council did not object but wished to comment that off street parking did not appear to have been provided for the original house and a S106 clause should be imposed.

Airfield – A letter from CYC Environment Protection updating Council on noise nuisance, enforcement notice and hangars public inquiry has been received. A decision on the hangars is expected from the Inspector before Christmas.
