**08/00455 – Kexby Stray Farm** – Remove hedgerows – Copies of letters from CYC. **Airfield** – Cllr Bailey gave an update on the result of the noise abatement trial appeal. It has been ruled that motor sport activities are causing an unlawful noise nuisance and

Elvington Park must abide by the noise abatement order served by CYC. A letter from the CYC Environment Protection Manager has been posted to the website.

- **9. Reports from recent meetings.** Cllr Rees reported on the RAF Reception in York. Cllr Wilson reported on the Village Hall. Cllr Webster reported on the Scouts.
- 10. Councillors' comments on previously circulated document. There were none.
- **11. Flooding matters.** The scheme has been completed. The Environment Agency are organising (and paying) for a commemorative plaque and an information board to be sited. John Grogan will attend an opening ceremony on Friday 4 July.
- **12. Tree Preservation Orders.** The Clerk is to ask the Tree Warden if there is a need to review new, potential TPOs. and if CYC has a map showing all existing TPOs. **DH**
- **13. Solar Panels.** The Clerk is to ascertain if an exhibition can be mounted to promote the use of energy efficient systems.
- **14. Mast/Turbine.** Cllr Rees reported on the issues being pursued and considered in case a full application for a turbine is received.
- **15. Ward Grants 2009.** Consideration is being given to requesting a Grant either for the new Play Area or resurfacing of the pavements on Main Street. **IB/DF**
