Reports from recent meetings. Cllr Wilson reported on the visit to the Maze. 9. Signage should be removed during close season by either the owners or CYC; walkers from Grimston Bar will be deterred; fireworks will be on 5/11. The Clerk reported on the YLCA York Branch Meeting. S106 procedures will be chased by YLCA. Cllr Bailey reported on the Ward Committee Meeting. Three Elvington schemes have been nominated but budget constraints may mean a cut back on amounts requested. Cllr Taylor reported on the School Governors. Cllr Wilson reported on the Village Hall. Cllr Webster reported on the Scouts. The Scout Bonfire Night will be on 7th November. Remembrance Day. Most of the arrangements are in hand. Outstanding are 10. police liaison; sound systems; road signs; hedges; refreshments. IB/TW/JW/DH 11. Senior Citizens. Cllr Rees proposed that the Senior Citizen volunteers be nominated for a Queens Award. This was agreed unanimously. Clerk to progress. DH Elvington Park. Cllr Bailey reported that signs may be sited by CYC to help 12. resolve the problem of HGVs entering the estate. Signage will also be checked at the Airfield Trading Estate to make it more visible for visiting lorries. IB/DH Highways, paths and verges. Water leak on Main Street is being investigated 13. currently. CYC will no longer replace footpath furniture.

14. Flooding Matters. The existing operating procedure remains until Ouse & Derwent Drainage Board take over responsibility for operation of pumping station.
15. Village Green. (a) Nothing to report on registration; (b) New Xmas lights & wiring will be ordered. Clerk to request that previous supply is disconnected and made safe.
