Elvington Park – Cllr Webster reported on the use of green belt land behind Elvington Park. Council agreed to discuss again at the next meeting allowing time for site visits to be made.

At a meeting with Sutton on Derwent Parish Council it was agreed to write to ERYC (copy to CYC) requesting a risk assessment on the health and safety aspects of pedestrian access across Derwent Bridge. **DH** The next Ward Committee meeting is at Wheldrake on Wednesday 29th April.

Village Green. A proposed agreement drafted by the objector's solicitors, formalising the return of the disputed land to its previous use, is still awaited.

13. Play Area. Feedback on the Council's application for 'Playbuilder' funding had
been expected some weeks ago but is still awaited. Cllr Bailey will chase.IB
MGMark Gillett is progressing the application for planning permission.MG

14. Bus Service. The new timetable has been circulated and will be posted on the website. The Clerk will write to CYC thanking them for the extra services but again pointing out the complexity of what should be a more 'user friendly' timetable. It was suggested all Councillors try the new service after its introduction
