<u>Precept.</u> **Minute 09045.** The Clerk reported on the Budget Sub Committee meeting. The budget for 2010/2011 was explained. Cllr Wilson proposed and Council agreed to approve an unchanged Precept for 2010/2011.

## 9. Planning Matters.

**Airfield.** Appeals have been made by Elvington Park to the Enforcement Notice and a new Noise Abatement Notice. Details are awaited from CYC.

**10.** Reports from recent meetings. Cllrs had discussed the Airfield with Chris Hudson and Nick Dewhirst of Elvington Park. Council reiterated it was not against activity at the Airfield, including motoring and aviation, but there has to be a balance with the needs of local residents. Elvington Park cited the obstacles it perceives are being imposed by CYC. It was suggested that Elvington Park produce a 'clean sheet' schedule of its proposed activities – and then meet the communities involved to try to agree a mutually acceptable way forward.

Cllr Rees reported on the Village Hall AGM at which Richard Pearce was elected the new Chairman. Cllr Webster reported on changes to the Scout Hut area.

- **11. First Response Team.** Cllrs Bailey and Taylor will produce an item for the next Newsletter. **IB/AT**
- **12. Bridge.** The Clerk reported that bridge repairs and resurfacing are scheduled to take place in Spring 2010. There is nothing yet to report on the proposed Environmental Weight Limit or pedestrian safety.
- **13. Village Green.** The Deed has been signed by both parties. But the objectors to registration of the Green will only withdraw their objection conditionally, which the Land Registry will not accept. The objectors are therefore drawing up a further document for signature, which is awaited. Council noted that this is incurring yet further expenditure.
- **14. Bus Services.** A proposal has been received for possible extra services at the beginning and end of weekdays. Council were in favour, although the timetable remains complex. It was also noted that the fares charged by the three operators who run services from the village to York are all different and not interchangeable. The Clerk will respond to CYC pointing all this out. **IB/DH**
- **15. Highways, paths and verges**. The grille and guage on the village green still need to be changed. A meeting with all parties to confirm the procedures in the event of a rise in river levels is to be progressed. **IB**
- **16. Items for Newsletter.** Lower cost housing; First Response Team
- 17. Items to be placed on next Agenda. Airfield.
