- **2. Apologies.** There were none.
- **3. Minutes.** The minutes of the meeting held on 17.2.2009 were signed as a true record.
- **4. Matters arising from the minutes not covered in this agenda.** There were none.
- **5.** Labour Party Candidate for York Outer. James Alexander described details of his background. Regarding the Airfield, he asked if a blanket petition to block any future planning applications should be initiated. Council decided to respond to any future planning applications on their individual merit.

**07/01606 – Plot E Airfield Business Park** – New units – Appeal withdrawn **08/01813 – Linden Lea, Elvington Lane** – Certificate of lawfulness – Request withdrawn **Northumberland House, Main Street** – Authority has been granted to remove two damaged sycamore trees provided they are replaced.

**10. Reports from recent meetings.** Cllr Bailey reported on the meeting with Chris Wise, the Sutton PC chairman. Issues discussed were a potential new footbridge over the River Derwent; the revised bus service; the phasing of the traffic lights; power generation from the Derwent; and allotments. Joint initiatives will be progressed when confirmation is received from Sutton.

- **11. Annual Parish Meeting.** Details of speakers and other arrangements were confirmed. The meeting will be on Tuesday 28<sup>th</sup> April.
- **12. Village Green.** Council were updated on the registration process. An agreement has been proposed to the objectors and a reply is awaited.
- **13. Play Area.** An application has been made to CYC for 'Playbuilder' funds. Cllr Taylor has suggested ways for community involvement. Mark Gillett is progressing further lottery funds, design details and the planning application.
- **14. Bus Service.** A new, regular off peak service operating every day except Sunday to York Merchantgate by York Pullman, to be known as Service 36 'The Village Link', will be starting on Monday 27<sup>th</sup> April. Final confirmation of timings is awaited from CYC. The new service will be promoted on the notice board, newsletter and website. **DH**
