Minute 11054. Council provisionally agreed the Budget and agreed that the precept for 2012/2013 would increase by 5.1% to produce an income of £12,350; (c) Minute 11055. A quotation for grass cutting in 2012 had been received from the existing contractor. This was agreed, along with his suggestion for a herbicide spray to be applied on the green in the spring. DH

Other Matters.

Former Allenby Nursery site. Cllr Bailey gave a report of the meeting with Home Group, CYC and the Architect in which further details of the proposed scheme were obtained, including the possibility of phasing. Council decided, without altering its opposition to the present scheme, to ask that any second phase would only proceed if the first phase was demonstrated to be occupied solely by people meeting the 'local' criteria. The Stables, Elvington Lane. Copies of correspondence from residents concerned whether planning conditions are being met have been received. The Parish Council will monitor the situation.

Airfield. No formal notification of the recent court decisions has yet been received.

11. Village Green. The award of a York Pride grant was confirmed. Cllr Wilson will arrange for the felling of the horse chestnut tree. The decision of which type of tree to replace it will be taken in the spring. тw

12. Environmental Weight Limit. The Clerk has drafted a case for applying for an EWL on Main Street between the School and the Bridge. Cllr Rees will first approach a specialist in order to seek his opinion on the proposal. PR

Queen's Diamond Jubilee. Various ideas for commemorating the Jubilee were 13. discussed including the commissioning of a commemorative mug, a seat, a tree; a hog roast and various events. The Parish Council has budgeted £1,000 for the celebration. The item will be on the next agenda for agreement. DF/PR/JW

**Emergency Plan.** Cllr Forster's reported on his meeting with CYC to discuss 14. various changes to the format, size and distribution of the Plan. He will update the current Plan for the next meeting. DF

Reports from recent meetings. Council heard that Santa's visit to the Village Hall 15. had been a great success!

Highways, paths and verges. (a) The extension of the 40mph speed limit to a 16. point near the Airfield and improved signage at several locations on B1228 between

Elvington and Grimston Bar will go ahead before the end of March 2012; (b) a resident was concerned about a kissing gate on the footpath near Red House Farm and CYC has agreed to investigate; (c) The Clerk will action reports of street lights not working and the Church Lane road surface at its junction with Main Street; (d) Cllr Taylor raised the problem of the bus waiting at Riverside being in a dangerous position. The Clerk will write to York Pullman to see if here is any alternative.
