**The Stables, York Road** – copies of correspondence received were noted. **Airfield**. Notification has been received that the Judicial Review and Application for Case Stated will be heard at Leeds Crown Court on 10/11<sup>th</sup> August starting at 10.0am.

10. Village War Memorial. It was agreed that Cllr Bailey be authorised to sign the form confirming Council ownership with the current owners of Blacksmiths Cottage. IB
11. Village Green. The condition of the horse chestnut trees was discussed – and the action that should be taken. It is some time since the last formal survey by a qualified arborialist. Two quotations had been received and it was agreed to ask, in the first instance, Toby Johnson to undertake a survey. Advance notification will be requested to allow Cllrs to attend – similarly with the CYC survey to be undertaken by Harvey Lowson. Council insurance documents will be reviewed to check coverage. IB/PR/DF/DH

12. Wintry Conditions. It was agreed that a follow up request be made to John Goodyear at CYC asking what progress on local action has been made for this year's wintry season. DH (cc GB)

**13.** Ward Grants. Minute 11031. Council agreed to submit a request for a Ward Grant of £4,000 to support a study into the possible introduction of an Environmental Weight Limit for the length of Main Street.

14. Reports from recent meetings. Cllr Rees reported on the last Ward Committee meeting (and walk) at Wheldrake Ings. He also reported on the Village Hall improvements being proposed. An invitation has been received for the retirement lunch of the Chief Executive of YLCA. The Clerk will reply that no one will be attending. DH
15. Highways, paths and verges. Cllr Nicholson reported on the condition of Dauby

Lane and possible subsidence of the verges. Cllr Bailey and the Clerk will progress. Cllr Barton reported two stretches of the B1228 will receive surface treatment in September. **16.** Ward Councillor. A general discussion with Cllr Barton took place in which

A general discussion with Clir Barton took place in which several issues were highlighted, including: <u>Bridge</u>: the decision of ERYC on the future of the weight limit is awaited. If the limit is removed then the Council will look at what can be done independently. <u>Speeding</u>: the increased number of checks is welcomed. <u>Road Surface</u>: GB was urged to ensure that work is budgeted for next year to resurface Main Street – and that CYC informs the Parish Council of its timetable. <u>Allotments</u>: GB announced that a Ward Grant of £1000 had been awarded to help the project to proceed.
