Minutes of the Meeting of the Parish Council held on Tuesday 28th June 2011 at 7.30pm in the Village Hall

MINUTES

- 1. Councillors Present. Cllrs Bailey; Rees; Forster; Nicholson; Webster; Wilson and 5 residents.
- 2. Apologies. Cllr Taylor.
- 3. Declaration of Interests by Councillors of any items on this agenda. Cllr Bailey declared a prejudicial interest in Item 10 concerning 1 Lorraine Avenue and Halgarth House, Dovecote Garth. Cllr Rees declared a prejudicial interest in Item 10 for Rosedene, Main Street. Neither Cllr took part in the relevant discussions or voted.
- **4. Minutes.** The minutes of the meeting held on 17.5.2011 were approved as a true record.
- 5. Matters arising from the minutes not covered in this agenda. (a) The Clerk will draft a letter for the owners of Blacksmiths Cottage to sign confirming Council ownership of the village war memorial. (b) Due to 'double counting' one S106 payment will not now be made by CYC. This creates a shortfall in the funding for the play area improvements of £481. The Clerk will write to ask for payment of this from CYC or the Parish Council will have to pay the money.
- 6. Land adjacent to The Conifers A request has been received from Home Group for help in establishing the demand for affordable housing in Elvington. Kerry Courts of CYC is also working with Home Group who want to contact interested respondents to the previous survey, question employees on the industrial estates and present their proposals at an exhibition locally. Council reiterated that it had no evidence of local demand for more affordable housing, but it will assist with the survey if requested. Council would not promote the scheme as that would affect its impartiality if a planning application is subsequently submitted. The residents present questioned the timescales of the surveys. Council has no information on this.
- **7. Police matters.** No crime report for May had been received. Monthly visits by a mobile police surgery will take place at the Sports Centre and Village Hall.
