Minutes of the Meeting of the Parish Council held on Tuesday 18th October 2011 at 7.30pm in the Village Hall

<u>MINUTES</u>

1. Councillors Present. Cllrs Bailey, Rees, Forster, Nicholson, Webster, Wilson + R Wood (CYC), N Dennison (JRHT) and 2 residents.

2. Apologies. Cllr Taylor.

3. Declaration of Interests by Councillors of any items on this agenda. There were none.

4. **Minutes.** The minutes of the meeting held on 13.9.2011 were approved.

5. Matters arising from the minutes not covered in this agenda. After consultation, it was decided extra lighting at the Play Area is not necessary.

6. Senior Citizen Bungalows. Nick Dennison (of Joseph Rowntree Housing Trust) admitted that recent communication about vacancies at Blacksmiths Close had been poor. The criteria for preferential tenancy were confirmed as aged over 60 and residency in Elvington. In future a notice will be sent to the Clerk by JRHT giving full details of any vacancy which will then be posted to the notice board for a week. Any interest in a property can always be registered with JRHT or the Parish Council in advance. ND/DH

7. Environmental Weight Limit. Richard Wood (of CYC) informed Council that a Traffic Regulation Order would be necessary to have an Environmental Weight Limit (EWL) introduced on Main Street. He described factors that would be considered, such as the current width and suitability of the road for lorries - and what benefits residents would get from an EWL, such as increased safety for pedestrians and the avoidance of nuisance and damage to residential properties. A case would have to be made to CYC Director of City Strategy. Consultations with the police and neighbouring authorities would have to take place before a decision was made. It was agreed:

- Richard Wood would inform Council of any other recent introduction of an EWL in CYC area, so that the Council could learn about the process
- Cllrs Bailey, Rees and the Clerk would meet to decide how to progress the matter
- The Clerk would keep Sutton on Derwent Clerk informed of developments and to ask ERYC for the traffic data which has currently been withheld. **RW/IB/PR/DH**

12. Village Green. Action on the chestnut trees was deferred until the next meeting. IB

13. Bus Services. For a case to maintain the subsidised early morning service a total of 19 passengers daily have to use the service (including the return evening journey). Actual figures from York Pullman have been received – but need clarifying. CYC are asking for a contribution from the parish to maintain their subsidy. It was decided to apply for ward funds to contribute to the cost and to explore whether any subsidy would be classified as 'double taxation'. DH

14. Allotments. Minute 11043. It has been established that the Parish Council is the responsible body in the relevant Act to consider the provision of allotments. The Clerk advised that the Parish Council had acted reasonably in providing start-up funds, information on landowners and other help to the Allotment Association and had therefore properly discharged their legal obligations. Also, the costs of compulsory purchase would outweigh any benefit to the community as a whole. The Council agreed to continue to liaise with CYC's Allotment Officer and to forward the YLCA advice to Jo Wedgwood. DH 15. Reports from recent meetings The Clerk reported on the YLCA York Branch

meeting and Cllr Webster reported on the latest situation at the Scouts.
