Minutes of the Meeting of the Parish Council held on Tuesday 20th August 2013 at 7.30pm in the Village Hall

MINUTES

1. Councillors Present. Cllrs Bailey; Rees; Forster; Nicholson; Taylor; Webster; Wilson + G Barton, Ward Cllr + 2 residents

2. Apologies. There were none.

3. Declaration of Interests by Councillors of any items on this agenda. Cllr Taylor declared an interest in Item 6 and took no part in the vote.

4. **Minutes.** The minutes of the meeting held on 16.7.2013 were approved.

5. Matters arising from the minutes not covered in this agenda. Cllr Barton explained the timetable for the Local Plan now that responses had been submitted to CYC. A further chance for the Parish Council to comment on the amended Plan will arise in 2014.

6. **Out of School Club.** Anne Kerr and Sue Challis described their plans to start the Out of School Club at the Sports Club. There was a recognised demand from parents and efforts to run such a club had been ongoing for some time. The children will form a 'walking bus' to get from the School to the Sports Club. The costs of setting up such a scheme include rent and insurance and the Parish Council was asked for a donation to help with those costs. Cllr Wilson asked if S106 monies could be used. This would be assessed if/when further monies are received.

Minute 13032. Council agreed unanimously to make a donation of £500 to cover start up costs as it was seen to be a very worthwhile scheme for the village.

7. Police matters. The crime report had been circulated to Cllrs. Only two crimes had been reported in July – a theft in Wheldrake Lane and an incident at the School.

New Applications.

13/02147 – Careval, Elvington Lane – demolition of bungalow and erection of dwelling.
13/02432 – Eversfield, Main Street – extensions and alterations (resubmission).
Minute 13034. Council had no objections to these applications.

13/02499 – Klein Copse – Church Lane – tree work

Minute 13035. Council had no objections but asked if severe pruning rather than felling would achieve the same objective.

13/02695 – Leaholme, 8 Roxby Close – extension and raise roof height **Minute 13036.** Council objected as the scale of the changes would be out of character for the house and the area.

Approvals. The following were noted:

11/0273 – Former Allenbys Nurseries, Wheldrake Lane – 18 dwellings. A copy of the S106 has been received and will be circulated to ClIrs. The new Registered Provider is the York Housing Association, who are planning to hold an 'information event' in the village. The issue of affordable housing and priority for Elvington residents will be on the agenda next month. Other Matters:

Airfield – Notification of appeal decision. CYC has been asked to provide a clarification of exactly what is and is not now allowed. This is awaited.

Eplanning – The new system has been introduced and the Clerk will monitor that all ClIrs receive the notifications from CYC. ClIr Forster asked for a more formal identification. **DH**

11. Risk Assessment. Minute 13037. Council agreed the annual review undertaken by Cllrs Rees and Webster. Next year the review will be extended to a check of assets.

12. Reports from recent meetings. Cllr Bailey reported that Julian Sturdy's MP surgery had recently taken place in Elvington as part of his regular schedule.

13. Highways, paths and verges. (a) The Environment Agency website link for the sluice gauges has been down for some time. EA has confirmed that this does not affect the operation of the flood defence scheme – but it does mean that residents are unable to monitor river levels. EA have promised to chase their national website team; (b) The bridge post over the beck on the village green has been repaired by CYC; (c) The Public Footpath linking Main Street with the Church is overgrown at the start. The Clerk will ask CYC to clear the path.
