The contractor cutting the grass in the village has pointed out that the area to be cut at the play area has increased and has submitted a revised quotation. **Minute 15017.** Council agreed to the revised cost of £150.00 per cut. **DH** 

## 9. Planning Matters.

New Applications. Minute 15018. Council had no objections to:

15/00628 – Cobwebs, Main Street – installation of dormer to rear

15/00749 – Puutalo, Main Street – tree work

Applications received after publication of this Agenda. There were none.

Approvals. The following were noted:

14/02844 – Laveracks Industrial Estate – erection of workshop/storage unit

15/00322 – Broad Oak Cottage, Dauby Lane – conversion of office to holiday let

<u>Appeal.</u> It was noted that the following refusal has been appealed:

14/01750 – Home Lea, Elvington Lane – change of use from touring to static vans <u>Other Matters.</u>

15/00638 – The Barn, Dauby Lane – conversion of agricultural building to dwelling. This is notification of a conversion under a General Permitted Development Order rather than a full application, and the Council is not being formally consulted. However, by majority, the Council were supportive of improving the site but thought the barn was still in use and that this may be a factor. The Clerk will respond accordingly. **DH** 

Water Treatment Works – Solar Panel scheme. Cllr Bailey reported on the site visit made by most Cllrs. The timescale of the application appears to have slipped. It was agreed that Council anticipate being supportive when the full application is submitted, subject to improvements in current screening.

S106 in lieu of open space provision. Cllr Bailey reported that current CYC policy appears to be <u>not</u> to impose S106 payments on small developments – and that this is current Government policy. Council thought that this was a serious loss of potential money which has to date been used to improve the play area or other open spaces. It was agreed that the new Parish Council should pursue the matter with YLCA and our MP. **DH** 

Elm Tree Farm, York Road. Cllr Bailey reported on an enquiry from the resident who is considering redeveloping the site. Council agreed to await details of the application.

**10. Village Green. Minute 15019.** Council approved the use of the Green for the Annual Fete and service on the weekend of 6/7 June. In addition, Council had no objection to the Grey Horse using the Green for a licensed bar, if it was in operation just for the afternoon, and subject to approval by the PCC. The Clerk will ensure the grass is cut. **DH** 

**11. Transparency Code.** To conform to the Code means putting further information on a publicly accessible website by  $1^{st}$  July. **Minute 15020.** It was agreed that the webteam will provide further pages on the Parish Council section of the village website. **AT/DH**
