- **11. Neighbourhood Plan.** Cllrs Laverack and Moorhouse reported that CYC has accepted the designation of the Neighbourhood Area. The next stage is to enter an agreement with CYC and apply for a grant. The draft document is awaited. **JL/MM/DH**
