11. Budget 2013/2014. Council agreed that a Sub Committee consisting of Cllrs Bailey, Rees and the Clerk should meet to set a provisional budget for 2013/2014 and report back to the December meeting. IB/PR/DH

12. Reports from recent meetings. There were none.

13. Emergency Plan. Cllr Forster presented the updated Plan which only awaits the addition of some mobile telephone numbers. When ready, the Plan will be circulated by email. Cllr Forster was thanked for this work on the Plan again this year. **DF/ALL**

14. Play Area. The annual survey should be undertaken by Playscheme shortly. The repair of the see-saw is taking longer than anticipated due to the difficulty in obtaining replacement parts from the manufacturer. **DH**

15. Highways, paths and verges. Since the resurfacing of Main Street has been completed, gullies still need to be cleared and a few temporary signs removed. CYC has said this will be done "in the next couple of weeks". Separately, the gullies in Dauby Lane draining into the dyke need to be cleared – and Yorkshire Water reminded to clear the dyke itself.
