#### **MINUTES**

**1. Councillors Present.** Cllrs Bailey; Laverack; Marsh; Moorhouse; Rees; Taylor; Wilson + 1 resident.

2. Apologies. Ward Cllr Mercer, who had provided an update on various issues.

To formalise the situation, agreement with the owners will be sought to license the siting of the boundary post/fence on Parish Council land.
