Minutes of the meeting of the Parish Council held on Tuesday 16th January 2018 at 7.30pm in the Atkin Room, Village Hall

MINUTES

- **1. Councillors Present.** Cllrs Bailey, Laverack, Marsh, Moorhouse, Rees, Taylor, Wilson + 2 visitors.
- **2. Apologies.** There were none.
- **3. Declaration of Interests** by Councillors of any items on this agenda. Cllr Laverack declared an interest in Item 11, Grass Cutting and took no part in the discussion or vote.
- **4. Minutes.** The minutes of the meeting held on 19.12.2017 were approved.
- **5.** Matters arising from the minutes not covered in this agenda. A visit from the Community Payback team is scheduled for April. Council asked that pavement widening should also be undertaken in the vicinity of the Surgery car park. **DH**
- **6. Village Green.** Two representatives from Keep Elvington Fun gave details of events they proposed to organise on the Green in 2018. **Minute 18001.** After discussion, Council agreed that Farmers Markets could take place on the third Sunday of each month between April and October, along with 'Easter Games' on 1 April and a 'Festival on the Green' on 22 September. The Parish Council retains the right, at its absolute discretion, to cancel any event if the underfoot conditions are considered unsafe. All vehicular access has to be prohibited at the top of the Green. It was also agreed that no events will take place between November and March (with the exception of the Carol Service and the Tug of War), to allow the Green to recover. All events will have public liability insurance provided by Keep Elvington Fun. The Clerk will write to confirm the arrangements.

Minute 18002. Council also agreed that the Chairman, in consultation with other Cllrs, would decide if any event should not proceed due to adverse weather or the condition of the Green.
