## 10. Planning Matters.

# New Applications.

18/01687 – Home Lea – change of use from agriculture to keeping of horses, construction of access and installation of septic tank (revised plan).

**Minute 18050.** Council still objected on three grounds. Horses are allowed to graze on agricultural land so there is no need to alter its designation; using Green Belt land to lay an access track when one already exists alongside is inappropriate and unnecessary; and there are no details of the existing septic tank which is to be replaced so the application is incomplete.

18/01786 – Water Treatment Works – in view of the changes made by Yorkshire Water, Council had no objections but asked for maximum screening.

- 11. Christmas 2018. Minute 18053. It was agreed that Cllr Wilson will arrange for the purchase and installation of the tree for the Village Green. He will liaise with other Cllrs on the installation day. Cllrs Rees and Bailey will sort out the lights. Minute 18054. It was agreed that the Green be used for tug-of-war on Boxing Day, subject to the usual proviso about underfoot conditions.

**17. Highways, paths and verges.** Councillors were concerned at the further delay to a traffic survey by CYC, which leads to a further delay for the proposed weight limit on Main Street. The traffic survey will now be undertaken in December.

The Clerk was informed of the flickering 20mph Speed Sign near the school and will write to get it repaired.
