Minutes of the Meeting of the Parish Council held on Tuesday 19th March 2019 at 7.30pm in the Atkin Room, Village Hall **MINUTES**

1. Councillors Present. Cllrs Bailey; Laverack; Marsh; Rees; Taylor; Wilson.

2. Apologies. Cllr Moorhouse.

4. Minutes. The minutes of the meeting held on 19.02.2019 were approved.

10. Village School. Cllr Bailey updated Council on the litter poster competition at the School, where he had attended the launch and prize giving. Ward Cllr Mercer had also contributed Ward funds. As this competition was so successful, a future one was suggested for next year potentially highlighting dog fouling problems. It was indicated that the Parish Council would likely contribute funding again.

11. Village Green. Minute 19021. A request by the Brownies for use of the Green on Easter Monday for duck races and fund raising was approved. **DH**

A general discussion on the problem of dog fouling on the Green took place. It was agreed that the Council may have to consider banning all dogs on the Green if the problem persists. The situation will be reviewed next month after a Newsletter item has been published. **DH**

12. Tour de Yorkshire 2019. Cllrs Laverack and Taylor updated Council on the various activities and arrangements made for Thursday 2 May. A giant screen has been ordered which will be funded by a CYC Ward Grant and donations from local businesses. Cllrs Laverack and Wilson will meet to confirm the exact location for the screen. The Air Museum will be displaying an exhibit and there will be various food and drink options. Bunting production is in full swing! The team will be presenting an update for residents at the Annual Village Meeting (see next item).

13. Annual Village Meeting. This will be on TUESDAY 9 APRIL at 7.30pm in the Village Hall. The formal business will be brief with the TdeY update being the main item. Cllr Rees will produce a poster for siting outside the Hall. Cllrs - and partners - were asked for help in serving refreshments afterwards. **ALL**

14. Recent and forthcoming meetings. Cllrs Rees and Wilson reported on the latest Village Hall meeting in which various maintenance work was agreed. They are also recipients of a CYC Ward Grant to fund redecoration.

15. Parish Council elections. The Clerk updated Council on the deadline for nominations to be received by CYC – 4.0pm on 3 APRIL. He is to take any nomination forms handed to him to CYC on 1 APRIL. Any election will be on 2 MAY. **DH**

16. Highways, paths and verges. The current extensive works in the vicinity of Elvington Park are for the installation of ducting for high voltage cabling to the sub-station there. Permission had been given for crossing the grassed area of the French War Memorial, and reinstatement has been done very neatly.

An anonymous offer to pay for new windows on the telephone kiosk has been received. The Clerk will progress with BT - as it is their kiosk – at the same time pointing out the rotten corner of the door frame. **DH**
