New Applications.

19/01938 – Derwent Valley Gun Club, Elvington Lane – certificate of lawfulness. The Clerk had been delegated to respond with 'No Objections'.

Cllr Laverack and the Clerk had been given access to the site that morning. Council was informed that Yorkshire Water state that the new tanks are 'permitted development'. The other ancillary buildings need permission. Whilst the site is largely masked from the village, it is visible from the river bank. Council will therefore comment that it has no objections but wishes the screening to be improved on the river side of the site.

Cllr Bailey asked that a rider be added stating that a limit has probably now been reached in any future developments on the WTW site.

**12. Village Green.** Residents had expressed concerns to ClIrs at the number of events on the Green, particularly those that were 'noisy'. It was recognised that with Tour de Yorkshire and Last Night of the Proms, more events than anticipated had taken place. Discussion also took place on whether local residents were the main supporters of these events. ClIr Gallery had concerns on the quality of the events being held. If events are proposed for 2020, Council is minded to restrict the number of events featuring live music. ClIr Laverack will speak with the landlord of the Grey Horse to establish his plans. **JL** 

Separately, the imminent Farmers Market may be barred from using the Green due to its waterlogged condition. The Green will not be used for the Market between November 2019 and March 2020. JL
