## **110/21 Highways, Paths and Verges**

- i. Becksideside crossing - Cllr Laverack to meet with Cllr Vassie and Mr G Mandell from CYC.  
Date and time to be arranged.
- ii. Wheldrake Lane - planned works have been scheduled. The Parish Council will try to determine whereabouts in the programme the works are.  
Work on the speed cushions outside the School is scheduled to commence on 18th October.
- iii. HGVs and speeding - planned meeting with Sutton upon Derwent Parish Council put on hold until the new Chairman is in place.
- iv. Community Payback Scheme - enquiries will be made as to when the scheme is resuming.  
Cllr Young informed the meeting that the Scouts will begin painting the maypole and the concrete bollards in a fortnight's time.  
Members of the Parish Council will carry out a Village Walk on Saturday 9th October, meeting at the Shop at 10.00am.
- v. Maintenance of river walk path - Cllr Young raised concerns about the condition and safety of the path. Cracked and falling willow trees are making the walkway unsafe. The Clerk will contact the

Right of Way Officer at CYC. Himalayan Balsam is also reported to be present but it is understood that this is no longer on the list of notifiable weeds.

**111/21 Legacy Project** - funding of £10k has been obtained for signage and advertising of the project. Cllrs Taylor and Lloyd will liaise on a posting of the project on Facebook.
