The clerk will convey this request to First York, together with regret at their non-attendance. First York will be invited to the September meeting. - **10.** Licence application in respect of the 'Grey Horse'. The council considered an application for the 'Grey Horse' to increase its hours. Cllr. D. Forster declared a financial interest at the outset. Observers were allowed to speak on the item. **Minute 05042** The councillors voted to ask for serving hours to be restricted to 2330 on Sunday (with 30 minutes drinking-up time) and 2400 on Mon.-Sat. - **13**. **Highways, paths and verges.** a) Mr. Soloman (CYC) is now working on the provision of vehicle-activated signs. The clerk will maintain contact on this issue. **D. R.**
