- 4. **Matters arising** from the minutes. a) Although there has been no formal notification it was reported that Elvington had been placed second in the recent Yorkshire Village of the Year competition.
- **5.** Buses in the Riverside area. From recent correspondence (xxv and xxvi) it was clear that there are still concerns about the reversing of buses in the Riverside region. For the convenience of observers, the chairman agreed to bring the discussion forward. The main recent complaint has been about buses reversing into Riverside Close, which is not seen as a safe practice. It was said that buses had caused damage to property in the past. One answer could be to extend the bus route to take in Sutton and Newton, removing the need to turn round in Elvington.
