- **9. Reports from recent meetings** a) Ward committee. A strong representation from the village had detected vehement feelings against the airfield developments. The list of approved grants showed that Elvington is being awarded four out of the five bids. b) Sports Club The new building is coming on well and within budget.
- **10. Flooding Matters.** The chairman confirmed that the Elvington scheme had been favourably received and had earned a recommended grant of £221,000. He went on to explain the proposed phases of the scheme and possible funding strategies. Cllr. Bailey paid special tribute to the hard work of his predecessors, Janice Stark and Eric Ingledew. The Environment Agency would take a leading role in any developments.

A public meeting is to be arranged in early April to inform residents of the possible sequence of events including ways of raising more money. The residents of Elvington Hall and Carr Masks are to be appraised of the implications. **D. R.**
