- 9. Flooding matters. a) The chairman informed council of the formal funding application letter. As it consisted of points previously agreed in council it had been sent out in order to avoid delay. b) It had been decided not to follow up the heritage lottery fund route, which was seen to be inappropriate. Instead a bid would be made for 'Awards for All'. c) Following meetings with C.Y.C., the Environment Agency, Ouse & Derwent Drainage Board, the chairman assured members that further funding is still being actively pursued. He reported that using portable pumps could result in substantial (not yet qualified) savings for the scheme. Minute 05051 The council agreed to accept the recommendation to use portable pumps. The chairman will monitor developments. I. B.
- 10. Highways, paths and verges. a) Yorks. Water has acknowledged responsibility for the dyke by Dauby Lane. b) Minute 05052 The council authorised an amount up to £100.00 for the erection of a sign on the green. I. B./ T. W. c) Cllr. Grimes observed that the footpath between Wheldrake Lane and the airfield still needs attention. Clerk will follow up. D. R.
- 11. Village of the Year. Cllr & Mrs. I. Bailey will attend the presentation at Thorpe Willoughby.
- 12. Play Area. No recommendation was made about possible work on the play area.
- 13. Change of Date. Minute 05053 It was agreed to change 18th July 2006 meeting to the 11th.
- **14. Matters arising from circulated documents.** There were none.
- **15**. **Reports from other recent meetings.** a) <u>Ward Committee</u>. Cllr Wilson reported that Cllr. Rees had spoken in favour of our bid for funding for the bus shelter. There had been a good discussion, with a useful contribution on refuse recycling. About £46K may be allocated for Ward Committee grants.
- b) <u>YLCA</u>. Cllr. Bailey informed council that a meeting mainly for Cllr. Galloway to answer a number of notified questions had been disappointingly bland. Not all questions had been included. One positive note was the leader's apparent confidence about central government financial support for CYC next year. c) <u>Youth Forum</u> Cllr. Forster

reported. The notion of a second night each week had been agreed in principle. Ways to use present funding, such as trips out on a weekend.had been discussed.
