- 9. Reports from recent meetings. a) Meeting with Dunnington P.C. The chairman reported on a meeting to discuss traffic congestion on the A 1079. He had urged that local councils should combine to press for improvements at Grimston Bar, Crockey Hill and Common Lane, Dunnington. b) School governors Cllr. Webster informed members of the appointment of a new Head Teacher. c) Sports Club Cllr. Rees had attended a recent meeting at which the future of the play area had been discussed. d) Youth Forum. Cllr. Forster had not been at the meeting but he reported the need for a new chairman to take over from Eric Ingledew.
- **10. Flooding matters.** a) <u>Meeting with owners of flood-affected properties.</u> Cllr Rees spoke of the intention to organise a fund-raising event to mark the opening of the flood scheme. b) The chairman referred to the need to keep options open, pending a firm response from City of York Council and others.
- 11. Airfield. Cllr. Bailey described a fruitful meeting with Ian Reed (Air Museum).
